

Terms of reference


- a) Previewing, scrutinizing and verifying all advertisements by individual contesting candidates or political parties, before inserting in the electronic media.
- b) Certification of Advertisements.
- c) Examining complaints/issue of paid news etc.
- d) Scan all media(e.g. newspaper, print, media, electronic media cable network ,internet social media , mobile network etc.) for:
 - i) Suspected cases of paid news.
 - ii) Monitoring of Political advertisements in electronic media.
 - iii) Monitoring of political advertisement in other media, in relation to candidates, either overt or covert, from Expenditure monitoring angle.
 - iv) Advertisement in print media.
 - v) Checking if the name and address of the publisher and the printer is carried on any election pamphlets , posters, hand bills and other documents as required under section 127 A of the RPA Act 1951.
- e) It shall submit a daily report to the Accounting team with copy to Returning Officer and Expenditure Observer in respect of each candidate in the Prescribed format (Annexure I of the prescribed Expenditure Guidelines).
